VII. Executive Director's Report.

- **A.** Operations:
 - 1. Pizza Thursday will be postponed until after winter break, due to the high numbers of COVID cases.
 - 2. Our transition to online learning before the break was a success. We received a lot of positive feedback.
 - 3. Dr. Sirko released the newest guidelines that all K-12 grade students are required to wear masks during school. The board reviewed the benefits and drawbacks of the mandate and decided that it would be best to follow suit and make the safest decision for the staff and students. Administration will put out communication about the transition to masks for all grade levels with the exception of Pre-K.

B. Instruction/Assessment:

- We are scheduling information meetings with our 8th graders about the IB program at Palisade Highschool and the STEM program through Central Highschool.
- 2. Our teachers continue to adapt to online learning and testing with ongoing training and professional development.
- 3. Administration will begin the UIP- including teacher input and feedback
- 4. Kati Bennett will attend training for continual renewal of the IACS induction program.
- C. Community Outreach, Mrs. Gonsalves
 - 1. IACS was able to provide a turkey dinner to one of our families.
- **D.** Culture. Mrs. Gonsalves
 - COVID burnout is evident in our teachers and students. Many have communicated a feeling of it never ending. Teachers are happy to be back in school and able to see their students in person. Teachers are really working hard for their students and trying to adjust on the fly for the needs of the school year. It is stressful, it is relentless and is taking its toll.
 - The board discussed different strategies to help the staff combat burnout. Some ideas were to look into services provided by Isa such as self care, what fills your cup, what recharges your battery.....
