#### A. Operations

- 1. The new floor plans and pictures for the auditorium are finished so we can use them to help raise money for the build.
- Our Charter still is up in the air as I have not heard anything back from the district but our lawyer is working on a draft we will turn into them so that we are situated. Amber DeCarli said since she has to write it it will contain all pro charter language.
- B. Instruction/Assessment
  - 1. We had 98% of students test in elementary and 97% in middle school so we hit major benchmarks for participation for our school.

- C. Community Outreach
  - 1. Change for Change raised \$7,000 for Dos Rios and will deliver bags of food to the school on Tuesday including \$4000 from community sponsors
  - 2. Robotics day was May 4th and was sponsored again this year by Alpine bank the theme was Mars recovery and students researched major disasters and the recovery from those major disasters - the kids had a great time and Alpine bank has agreed to keep this tradition moving into next year.
  - 3. The Arts and Music festival was a BIG success this year and the Phoenix Family raised \$3700 from the silent auction, which will go to help support the arts programs.
  - 4. Wild Wild West Fest put on by the middle school was a huge success they taught elementary school all about the wild west.

#### VIII. Executive Session CRS Section 24-6-402 (4)(f)
